2. Ran 10 jts. 8-5/8", 24.0#, J-55 casing. Landed at 330 ft. R.K.B. Cemented with 250 sacks regular cement. Plug down at 12:00 noon 9/29/67.
3. Nippled up and pressure tested surface casing to 1000 p.s.i. for 15 minutes. Test OK.
4. Drilled out from under surface casing with 7-7/8" hole 9/30/67.
