1. Spudded 12-1/4" surface hole 10/11/67. Drilled to total depth of 343 ft. R.K.B.
2. Ran 10 jts. 8-5/8", 24.0#, J-55 casing. Landed at 342 ft. R.K.B. Cemented with 250 sacks of regular cement. Plug down at 11:00 A.M. 10/12/67.
3. Nippled up and pressure tested surface casing and blowout preventor to 800 p.s.i. for 15 minutes. Test OK.
4. Drilled out from under surface casing with 7-7/8" hole on 10/13/67.
