We propose to drill a Dakota well; anticipated total depth 7350 ft.

- Casing Program: Surface: 8-5/8", 24.0#, J-55 set at 300 ft. cemented w/250 sacks.
Production: 4-1/2", 10.50#, J-55 set at total depth of 7350 ft. R.K.B. 1st stage cemented w/700 cu. ft. of cement; stage collar set at approx. 5450 ft. under Mesaverde and cemented w/900 cu. ft. cement; stage collar set at approx. 3000 ft. under Piutered Cliffs and cemented w/1200 cu. ft. cement.
- Rotary tools will be used to mud drill well from surface to total depth.
- Well will be sand fraced to stimulate production.
- 1-1/2", 3.0#, 2.90#, tubing will be set at approx. 7200 ft. R.K.B.

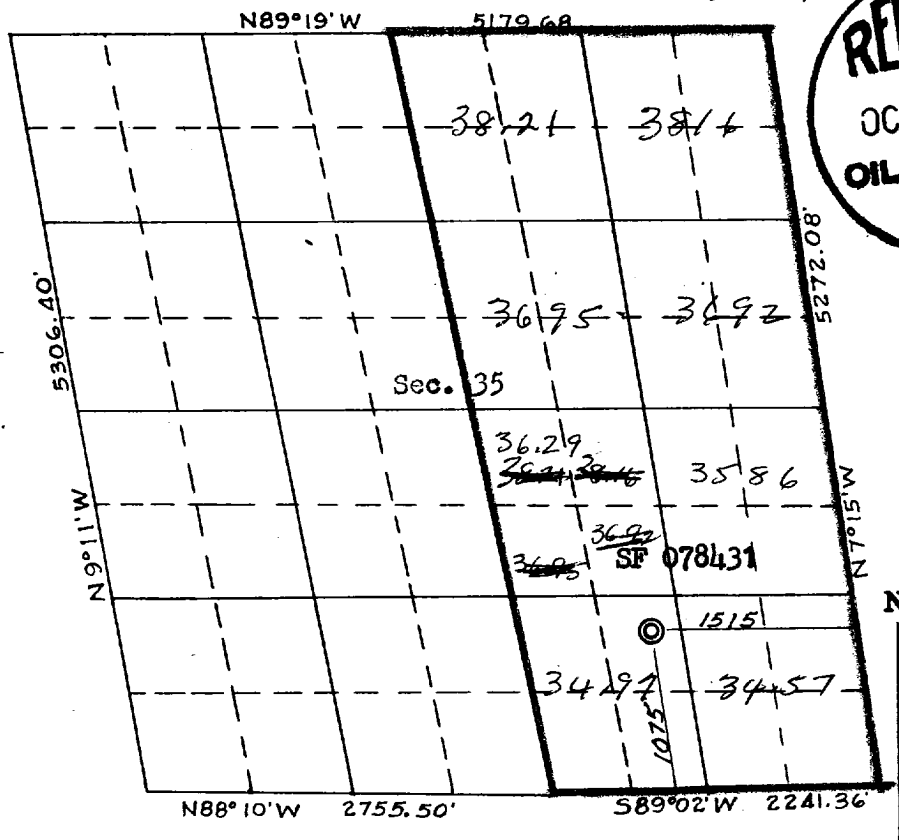
