Bayless again requests to be excused from your requirement that we conduct an MIT on this well. We now have this well on pump; along with other wells that were also returned to pump recently. As a result of this work, field production has increased from 30 to 160 BOPD.

When an MIT is done, up to 200 BW is dumped on the formation. Past experience in the field indicates that this can alter the near well relative permeability to oil. A much higher near-wellbore water saturation makes it easy for water to flow through the formation but difficult for oil. Both Amoco and Bayless have experienced this phenomena.
