On 5-24-68 Total depth 6868'. Ran 215 joints 4 1/2", 10.5", J-55 casing (6856') set at 6868'. Float collar set at 6860', second stage tool at 4910', third stage tool at 2410'. Cemented first stg. w/270 sks. cement, second stg. w/190 sks. cement, third stage w/200 sks. cement. W.O.C. 18 hours.

On 5-25-68 P.B.T.D. 6860'. Tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% HCL. Perf. 6600-10, 6623-28, 6639-44, 6680-98, 6712-22, 6742-60' w/18 SPZ. Frac w/70,000# 40/60 sand, 72,030 gal. water. Max. pr. 4000#, BDP 3360#, tr. pr. 2600-3400-3700#. I.R. 42 BPM. Dropped 5 sets of 18 balls, flushed w/4536 gal. water. ISIP 1300#, 5 Min. 1000#, 15 Min. 800#, 30 Min. 600#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
