



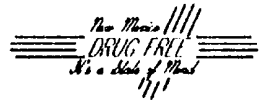

If you do not respond by June 25, 1993, a case will be docketed for hearing to show cause why referenced wells should not be plugged and abandoned in accordance with a Division approved plugging program.
