On 6-28-69 ran 7 joints 8 5/8", 24#, K-55 casing (219') set at 231' w/160 sacks of cement circulated to surface. W.O.C. 12 hours, held 600#/30 Min.

On 7-10-69 T.D. 6831', ran 249 joints 4 1/2", 10.5#, J-55 casing (6619') set at 6831', float collar set at 6818', second stage tool at 4917', third stage tool at 2351'. Cemented first stage w/260 sacks of cement, second stage w/215 sacks of cement, third stage w/220 sacks of cement. W.O.C. 18 hours.

On 7-11-69 P.B.T.D. 6818', perf. 6714-22', 6734-42', 6797-6807' w/20 SPZ. Sand water frac w/40,000# 40/60 sand, 45,250 gal. water, flushed w/4600 gal. water. Dropped 2 sets of 20 balls. Set bridge plug at 6680', perf. 6632-42', 6655-60' w/20 SPZ. Sand water frac w/35,000# 40/60 sand, 38,000 gal. water, flushed w/4500 gal. water. Dropped 1 set of 20 balls.

Instructions
