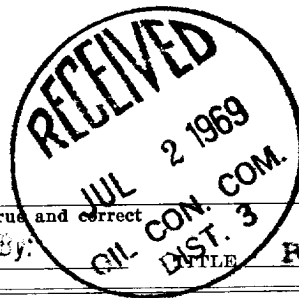

On 6-13-69 Spudded well, drilled surface hole and ran 7 joints 8 5/8", 24#, J-55 casing (222') set at 235' w/160 sacks of cement circulated to surface. W.O.C. 12 hours, held 600#/30 Min.

On 6-35-69 T.D. 6677', ran 204 joints 4 1/2", 10.5#, J-55 casing (6666') set at 6677' w/float collar set at 6665', second stg. tool at 4720', third stage tool at 2105'. Cemented first stage w/260 sacks of cement, second stage w/180 sacks of cement, third stage w/160 sacks of cement. W.O.C. 18 hours.

On 6-26-69 P.B.T.D. 6659', tested casing to 4000# O. K. Spotted 250 gal. 7 1/2% HCL. Perf. 6430-40', 6461-66', 6519-39', 6583-93', 6644-49' w/20 SF2. Flow w/60,000# 40/60 sand, 74,000 gal. water. Max. pr. 4100#, BHP 2600#, avg. tr. pr. 3500#, I.R. 35 BPM. Dropped 4 sets of 20 balls, flushed w/4200 gal. water. BHP 1700#, 5 Min. 1600#, 15 Min. 1600#.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
