On 4-11-70 spudded well, drilled surface hole.

On 4-12-70 ran 7 joints 8 5/8", 24#, KS casing (216') set at 228' w/160 sacks of cement circulated to surface. W.C.C. 12 hours, held 600#/30 min.

On 4-25-70 T.D. 7011'. Ran 214 joints 4 1/2", 10.5#, J-55 casing (6999') set at 7011'. Float collar set at 6998', second stage tool at 5051', third stage tool at 2511'.

Cemented first stage w/270 sacks of cement, second stage w/210 sacks of cement, third stage w/245 sacks of cement. W.O.C. 18 hours.

On 4-26-70 P.B.T.D. 6969'. Perf. 6940-46' w/24 shots, frac w/13,000# 10/20 sand, 13,500 gal. water, no ball drop, flushed w/2100 gal. water. C.O. sand to 6900'.

On 4-27-70 Used sand fill up for BP, tested O. K. Perf. 6854-79' w/50 shots. Frac w/50,000# 10/20 sand, 24,000 gal. water, no ball drop, flushed w/4700 gal. water. Set BP @ 6825', tested to 4000# O. K. Perf. 6762-74', 6792-98' w/24 SPZ. Frac w/52,000# 10/20 sand, 33,300 gal. water, dropped 1 set of 25 balls, flushed w/4636 gal. water.
