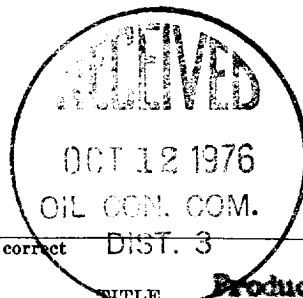

Due to the uneconomic status of the Newton No. 21, it is therefore intended to plug and abandon the subject well as follows:

1. Rig up and pull 2-3/8" E.U.E. tubing.
2. Pump class "A" cement plug from T.D. 2286 ft. - 2101 ft.
3. Perforate and squeeze 4-1/2" casing at 1600 ft. w/160 lbs cement.
4. Pump 50 ft. cement plug in surface at 140 ft. to 90 ft.
5. Put 10 ft. plug at surface and set Dry hole marker.
6. Restore location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
