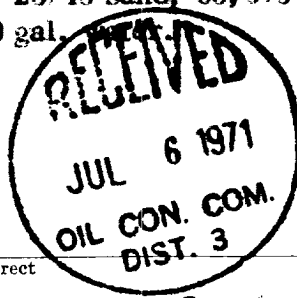

6-21-71 P.B. T.D. 7015'. Perforated 6775-31', 5808-14', 5860-72', 6912-24', 6936-42' w/18 SPZ. Fraced w/60,000# 20/40 sand, 60,590 gal. treated water. Dropped 4 sets of 18 balls, flushed w/4810 gal.
