PXA Procedures
Blanco LS #19

1. MIRUSU. Blow down well. Kill if necessary with fresh water. NDWH. NUBOP.
 2. RIH with 1 1/4" workstring and cement retainer, set retainer at 3180'. Test casing integrity to 500#. Squeeze perfs at 3230' to 3250' with 8.633 cuft cement. Pull out of retainer and spot cement plug to 1930' with 60.93 cuft cement.
 3. Run in hole with perf gun and shoot squeeze holes at 1900'. RIH with tbg and cement retainer, set retainer 50' above squeeze holes and attempt to circulate to surface with 148.50 cuft cement. Pull out of retainer and fill hole to surface with 92.625 cuft cement.
 4. NDBOP. Cut of casing and wellhead. Install PXA marker according to BLM or State requirements.
 5. Turn over to John Schwartz for reclamation.
 6. Rehabilitate location according to BLM or State requirements.
