The Navajo Tribal "N" No. 12 was perforated 6276-82' and 6264-70' with 2 SPY. Spotted 250 gallons 15% HCl over perforations and soaked for 20 minutes. Breakdown pressure 2150 psi. Pumped 500 gallons 15% HCl and well on vacuum. Dropped 15 balls with no action. Pumped 500 gallons 15% HCl with ISIP vacuum. Set a Model "D" Packer at 6273' to swab and flow test the lower zone with lower zone making water and trace of oil.

Instructions
