Maximum cementing pressure 500 psi. Bumped plug with 1500 psi. Held O.K. Left shut-in with 750 psi. P.O.B. 11:45 a.m. 3-31-73. Followed plug with 100 gallons 10% acetic acid. Released rig 12:00 noon 3-31-73.
