PLUGGING PROCEDURES
LARGO FEDERAL #6

- 1) Set CIBP @ 3840' and spot 50' of cement on top of plug
 - 2) Perf @ 2739', place cement plug from 2739' to 2639' inside and outside the casing plus 100% excess cement in the annulus with an additional 50 linear feet inside the casing.
 - 3) Perf @ 2248', place cement plug from 2248' to 2030' inside and outside the casing plus 100% excess in the annulus with an additional 50 linear feet inside the casing.
 - 4) Perf @ 1228', place cement from 1228' to 1128' inside and outside the casing plus 100% excess in the annulus with an additional 50 linear feet inside the casing.
 - 5) Perf @ 185' and circulate cement to surface.
