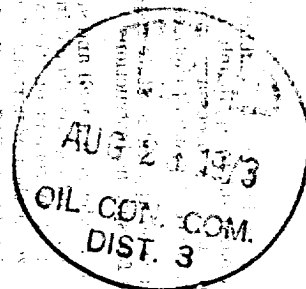

Frac'd with 30,230 gals. conds. with 26,700# 20/40 sand. Average pressure 4450 psi @ 15.6 BPM. Swabbed and blew clean. Well SI 8/20/73 pending AOF.

Instructions
