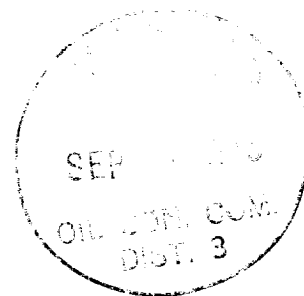

The well was spudded August 17, 1973 with a 12-1/4" bit and drilled to 132'. The hole was then reamed with a 17-1/2" bit to a depth of 132'. The 13-3/8" casing was set at 129' with 100 sacks cement on August 17, 1973. The cement did not circulate but after checking hole found cement one foot below the surface. The casing was pressure tested with 600 psig for 1/2 hour OK, and the hole reduced to 12-1/4" at 132'. Continued drilling to 1500', encountered a 2" water flow at 1210', and set the 9-5/8" casing at 1500' on August 22, 1973, with 450 sacks Class "C" cement with 4% Gel and 2 pounds medium Tuf Plug per sack followed by 100 sacks Class "C" Neat. Circulated 15 sacks cement and the water flow was shut off.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
