Circulated hole clean. Ran 183 jts. 5-1/2" 15.5# casing to 5965' and cemented in two stages. Stage 1: 200 sacks Howco Lite plus 10% salt followed by 100 sacks class "A" Latex. Plug down 1:05 am 9/12/73. Stage 2: 300 sacks Howco Lite plus 10% salt. Plug down 5:45 am 9/12/73. Good circulation though out both stages. WOC.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
