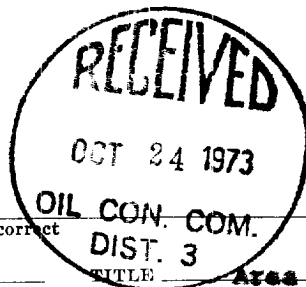

A 12-1/4" hole was spudded October 11, 1973 and drilled to 100' then reamed to 17-1/4" to 98'. The 13-3/8" casing was set at 97' with 125 sacks Class "A" with 2% CaCl₂, October 12, 1973. Circulated 15 sacks cement.

The hole was reduced to 12-1/4" at 100' and drilling continued with a 2" water flow encountered at 839'. The 2" flow increased to 4". Drilling continued to 1600' with the 9-5/8" casing set at 1595' on October 15, 1973, with 550 sacks Class "A" cement with 42 Gal and 2 lbs. medium Tuf Plug per sack followed by 100 sacks Class "A" Neat. The cement circulated and the water flow was cut off. The hole was reduced to 8-3/4" at 1600' and drilling continued.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
