Plan for Navajo Tribe "BP" No. 2, San Juan County, New Mexico, is as follows:

- Existing roads and exit to the location are shown on the attached plat.
- Approximately two-tenths of a mile of access road will be required as shown on attached plat. The road surface will be compacted soil.
- 3. Nearest producing well is located three-quarters of a mile to the northwest in Section 27.
- 4. Lateral roads in the vicinity of the location are shown on the attached plat.
- 5. The flowline for the proposed well will run to an existing battery located a mile to the southwest of the location, see attached plat.
- 6. Water for drilling operations will be obtained from the bradenhead annulus of Texaco's Navajo Tribe "AR" No. 1, located a mile to the southwest.

- 7. All waste material will be contained by earthen and steel pits. Earthen pits are to be subsequently backfilled and buried.
- 8. No separate drill campsites are proposed.
- 9. There are no FAA registered airstrips in the vicinity of the location.
- 10. The drillsite location will be laid bare and vill be approximately 250' x 300'. Proper grading will be used to control erosion on the location. A plat showing the location and rig layout is attached.
- 11. All surfaces not used in normal well servicing and maintenance will be cleaned and graded, where necessary.
- 12. The wellsite is located on gentle sloping, sandy, barren ground, with widely scattered clumps of sage brush and/or tumbleweeds.

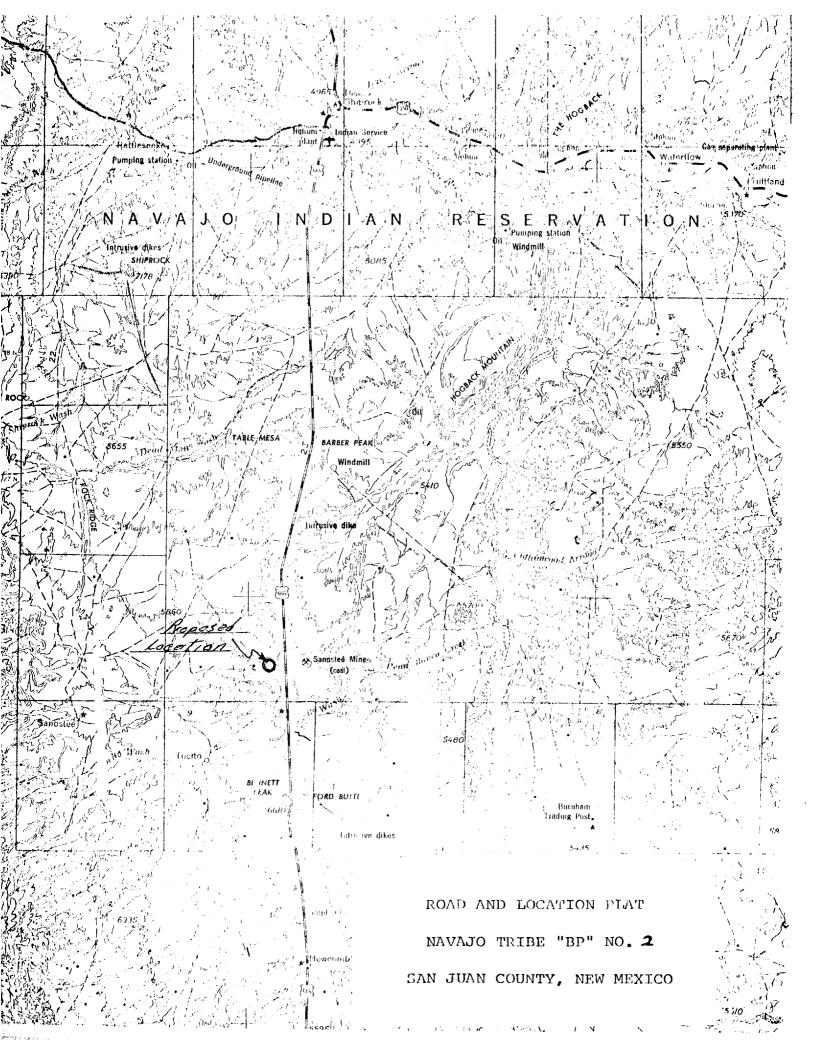

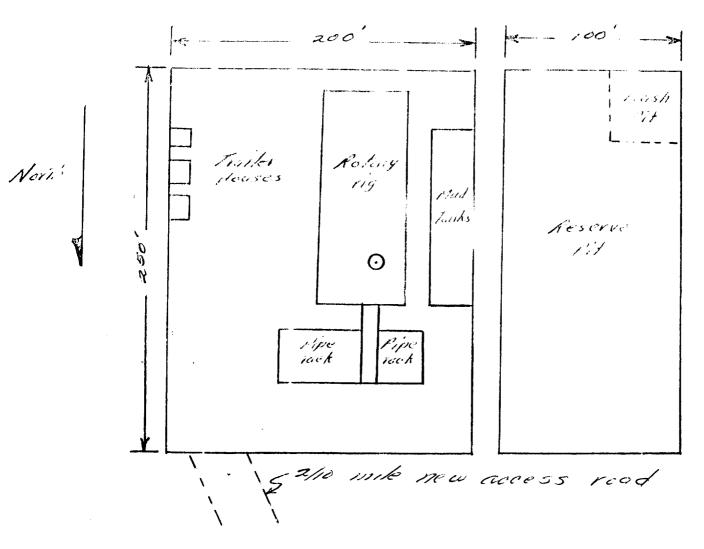
