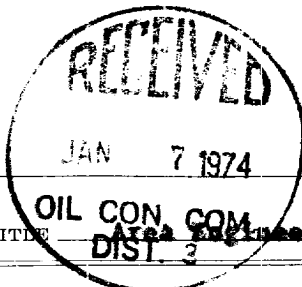

The Navajo Tribal "U" No. 17 was spudded with a 12-1/4" surface hole on December 10, 1973, and drilled to 11'. The hole was reamed to 17-1/4" and the 13-3/8" casing set at 106' with 115 sacks Class "A" cement with 22 CaCl₂ on December 11, 1973. The hole was reduced to 12-1/4" at 109' and drilling continued to 1501'. While drilling at 1372' a 3-1/2" water flow was encountered. The 9-5/8" casing was set at 1501' with 500 sacks Class "A" Heat cement with 42 Gel and 2 pounds medium Tuf Plug per sack. Tailed in with 75 sacks Class "A" Heat cement. The cement circulated on both cementing jobs. Reduced the hole size to 8-3/4" at 1501' and continued drilling.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
