1-24-74: Ran 3 joints, 92', of 13-3/8" OD, 48#, R-40, ST&C casing set at 90' KB. Cemented with 125 sacks regular cement with 3% CaCl. Plug down at 2:30 a.m. 1-24-74.

1-26-74: Ran 42 joints, 1,620', of 9-5/8", 36# & 32.30#, K-55, ST&C casing, set at 1615', cemented with 1600 sacks Class "B" Howco Lite, tailed in with 100 sacks regular with 3% CaCl. Plug down 10:20 a.m. 1-26-74 with 1000 psi. Cement circulated to surface. Tested BOP and casing with 800 psi for 30 minutes, pressure held okay.

2-20-74: Ran 152 joints, 6,506', of 7" OD, 23# & 26# buttress casing, set at 6499' KB. Cemented with 300 sacks Class "B" cement with 6 1/4# gilsonite, 7# salt, 1# mud kill and 3/4 of 1% CPR-2 per sack. Plug down at 10:00 a.m. 2-20.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
