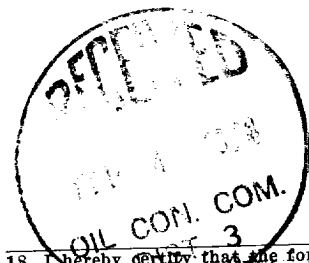

TIGHT HOLE

A 12-1/4" surface hole was spudded January 10, 1974 and drilled to 125'. The hole was reamed to 17-1/4" to 122' with the 13-3/8" casing set at 122' with 125 sacks Class "A" cement with 2% CaCl₂ on January 12, 1974. Waited on cement to set and tested casing to 500 psi and "OK". Reduced the hole to 12-1/4" at 122'. Drilled hole to 1496' where the 9-5/8" casing was set and cemented with 500 sacks Class "A" with 4% CaI and 2 pounds medium Tuf Plug per sack on January 15, 1974. The cement circulated. The hole was reduced to 8-3/4" at 1496' and drilling continued.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
