Due to the failure to find commercial quantities of hydrocarbons, the subject well was plugged and abandoned on August 9, 1974. The 7" casing was cut at 3225' and 3225' of casing pulled. Cement plugs were spotted as follows:

100 sacks Class "A" cement 3830-4320'.
100 sacks Class "A" cement 2940-3320'.
100 sacks Class "A" cement 1370-1600'.
20 sacks Class "A" cement 50' to surface.

The wellhead was cut off and a P&A marker erected. The location was cleaned up and reseeded.

Instructions
