The subject well was drilled to a total depth of 6490' and on 3-7-75 the 7" casing was set at 6486' with DV tool at 4286'. The casing was cemented in stages with first stage consisting of 375 sacks Class "B" with 6X Gel and 2 pounds medium Tuf Plug per sack followed with 150 sacks Class "B" Neat. Second stage cement consisted of 850 sacks Class "B" Neat with 6X Gel and 2 pounds medium Tuf Plug per sack with tail in of 150 sacks Class "B" Neat. Circulated cement and waited on cement to set. Drilled DV tool and cleaned out well to FSD 6445'.

Instructions
