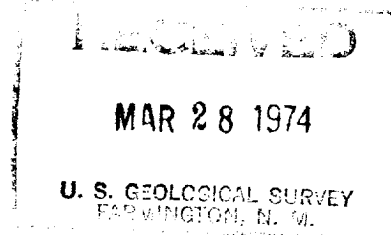

A 12-1/4" surface hole was spudded on March 23, 1974, and drilled to 117'. The hole was reamed to 17-1/4" to a depth of 117' with the 13-3/8" casing set at 116' with 125 sacks class "A" cement with 22 CaCl₂ on March 24, 1974. The cement circulated. Tested the blowout preventer and casing to 600 psig and OK. Reduced the hole to 12-1/4" at 115' and drilling continued.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
