A 12-1/4" hole was drilled to 1508' where on 10-13-74 the 9-5/8" casing was set with 500 sacks Class "B" cement with 4% Gel and 2 pounds medium Tuf Plug per sack. Tailed in with 150 sacks Class "B" Neat. Circulated the cement. Waited on cement to set 18 hours and pressured casing to 900 psi for 1/2 hour OK. The hole was reduced to 8-3/4" and drilled to a total depth of 6570'. On 10-31-74 the 7" casing was set at 6570' with DV tool set at 4310'. First stage cement consisted of 500 sacks Class "B", 50-50 Poz, 6% Gel and 2 pounds medium Tuf Plug with a tail in of 250 sacks Class "B" Neat. Second stage cement consisted of 800 sacks Class "B" Neat, 50-50 Poz, 6% Gel, 2 pounds medium Tuf Plug followed by 150 sacks Class "B" Neat. The cement circulated on both stages.

Instructions
