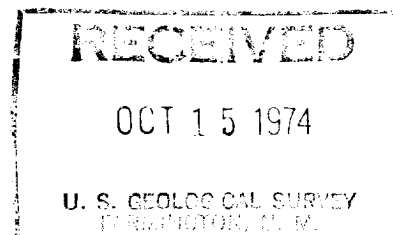

Cemented first stage with 500 sacks Class "A" with 50:50 Pozmix, 6% Gel and 2 pounds medium Tuf Plug per sack with a tail in of 200 sacks Class "A" Neat. Cemented second stage with 900 sacks Class "A" with 50:50 Pozmix, 6% Gel and 2 pounds medium Tuf Plug per sack with a tail in of 150 sacks Class "A" Neat. The cement circulated.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
