A 12-1/4" surface hole was spudded 8:00 p.m., 12-20-74. The hole was drilled and reamed to 17-3/4" to 132'. The 13-3/8" casing was set at 129' with 195 sacks Class "B" cement with 2% CaCl on 12-21-74. The cement circulated. WOC 16 hours and pressure tested casing with 800 psi for 1 hour OK. The hole was reduced to 12-1/4" and drilling continued.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
