Core No. 3 - 6464-6518' cut and recovered 54'.

Ran tubing and bit and drilled well to a total depth of 6565'. On 1-14-75 set 7" casing at 6565' with 240 sacks Class "A" Neat cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
