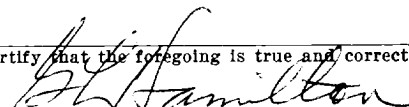

A 12-1/4" hole was spudded at 1:15 PM on 4-19-75 and drilled to 124'. A 17-1/4" hole was reamed to 124' where on 4-20-75 the 13-3/8" casing was set with 135 sacks Type "B" cement with 2% CaCl₂. Circulated 3 sacks cement. Waited on cement to set 17 hours and tested BOP to 400 psi 1/2 hour OK. Reduced hole to 12-1/4" and continued drilling to 1503' where the 8-5/8" casing was set with 450 sacks Class "B" cement with 4% Cel, 2 lbs. medium Tuf Plug per sack followed with 150 sacks Class "B" Heat on 4-21-75. Circulated the cement and waited on cement to set 17 hours. Pressured casing to 800 psi for 1/2 hour OK. Reduced hole to 7-7/8" at 1503' and continued drilling.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
