Plugged and abandoned the subject well as follows on 6-24-86:

1. Filled 2-7/8" OD, 6.5#, C-45-100, EUE R-1 tubing for casing using 35 sx (41.3 cf) of class "B" neat cement. Placed 6 sx (7 cf) of cement down backside of 2-7/8" tubing for casing.
2. Installed permanent dry hole monument.
3. Filled all pits.
4. Cleaned well location of all equipment, pipe, junk and trash.
5. Dugan Production Corp. is now preparing surface restoration, reseeding in accordance with Environmental Stipulations (Section #3) approved in APD.
6. Cut off tie-downs.
