Circulated good cement to surface through the bradenhead. SI the bradenhead and pumped another 15 sx ( 18 cu.ft.) of CI "B" cement. Pressured to 600 psi and held. Cement level dropped 6' in four hours. BLM witnessed the job. Installed dry hole marker and cleaned up the location.
