Gentlemen:

Ms. Linda Taylor of the Bureau of Indian Affairs, conducted the two inspections below for final abandonment surface clearance. Ms. Taylor's comments are as follows:

- 1) Lease NM 0560223, Navajo Nation surface, Frew Federal No. 7, 1190'S/790'W, Section 19, T26N, R12W, San Juan County, New Mexico.

This plugged and abandoned location is recommended for final surface clearance.

- 2) Lease NM 16473, Navajo Nation surface, Hanlad Federal No. 3 Dome Petroleum Corp. 1650'S/990'E, Section 31, 26N, 12W, San Juan County, New Mexico.

Texaco purchased this well from Dome Petroleum Corp. This plugged and abandoned location is recommended for final surface clearance.

Bureau of Land Management, Farmington District Office, will be provided a copy of this letter to notify them of our recommendations for the two locations.
