SUNDRY NOTICE SUBMITTAL

Well: Lively #18E

Unit D, Sec. 1, T 26N, R 8W
San Juan, NM

It is intended to recomplete the Chacra and Mesaverde formations in the existing Dakota wellbore. A rig will MIRU, ND wellhead, NU BOP, and pull production tubing. A CIBP will be set above the Dakota formation at approximately 5015'.

If adequately isolated by cement, the Mesaverde will be perforated and fracture stimulated in one stage in the following interval: 4515' - 4915'. If adequately isolated by cement, the Chacra will be perforated and fracture stimulated in one stage in the following interval: 3142' - 3520'. If cement remediation operations are necessary, Burlington Resources will contact the appropriate regulatory agency for approval prior to work initiation.

After stimulation flowback, the CIBP above the Dakota will be drilled out and tubing will be landed approximately 100' above PBTD. The well will then produce commingled production for the Chacra, Mesaverde and Dakota formations. Application for commingling will be submitted.
