Cross Timbers proposes to plugback the O.H. Randel 6E from the Dakota formation to the Gallup formation per the following procedure.

1. MIRU PU. Set cement retainer @ 6,225'.
2. Squeeze DK formation with 50 sx cl "B" cement. Spot 4 sx cl "B" cement on retainer.
3. Perforate Gallup formation from 5,388'-98', 5,408'-17', 5,442'-50' and 5,516'-50'.
4. Fracture stimulate the Gallup formation.
5. Clean out well.
6. RDMO PU. Put well on production.
