Rig up Farmington Well Service 1/11/82. Tag up cement wiper plug at 651' with sinker bar. Pressure test casing to 1000 psi for 30 minutes. Held OK. Trip in hole with 1-1/4" tubing. Push wiper plug to 681'. Rig up power swivel and James Drilling. Drill rubber plug and cleanout hole to 723'. Cement is hard and will not drill. Last 2' cement took 6 hours to drill. Suspend operations per verbal telecon on 1/20/82 between A.L. Kuchera and Frank Chavez. It is planned to completethis well in the Farmington sand at 636'-644' and 606'-610' pending cement bond log survey.
