Well Plugged and Abandoned September 14, 1993

Plugging Summary:

Drive rig and equipment to location. Rig up and spot equipment; lay relief line to pit. Open well up and bleed down. ND wellhead and NU BOP. POH and tally 18 joints 1-1/4" IJ tubing, 596'. Pumped into bradenhead valve and pressured up to 1500#. Procedure change approved by K. Schneider with BLM; not necessary to perforate. RIH with open ended tubing to 595' and pump 10 bbls water. Plug #1 from 595' to surface with 31 sxs Class B cement. Circulate good cement to surface. Pull tubing and LD. Shut in well and dig out casing head. Open well up and ND BOP. Cut off wellhead and fill casing with cement, then install P&A marker; total 25 sxs cement. Cut off anchors below ground level. Rig down and move off location.

Cement Plugs:

Plug #1 - from 595' to surface with 31 sxs Class B cement, circulate good cement to surface.
