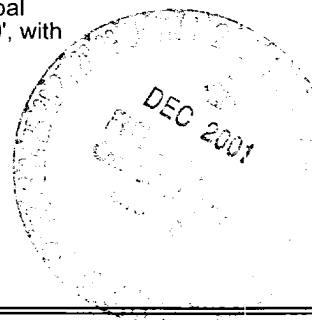

Work commenced on the above mentioned well to recompleat to the Blanco Mesaverde, but, due to numerous holes detected in the casing, recompleat procedure was aborted. Received verbal approval from Steve Mason on 11/19/01 to run packer to isolate holes, packer will be @5800', with tailpipe to mid-DK perms. This is a temporary fix and further evaluation will be done to either repair casing of plug and abandon well. Evaluation will be completed by 04/01/02.
