Spudded surface at 10:30 a.m. on October 8, 1990. Drilled 8-3/4" hole to 135'. Ran 3 jts. (131.9') of 7", 20#, J-55, 8rd, ST&C casing. Casing set at 132.23'. Mixed and pumped 60 sks. (70.8 cu. ft.) Class "B" cement containing 2% CaCl2 and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 1500 psi for 30 minutes; test ok.
