Drilled out from under casing with 7-7/8" bit December 20, 1990. Drilled to TD of 5425'. Ran Induction Log with Gamma Ray and Compensated Density-Neutron logs. Log tops as follows: Fruitland Basal Coal - 1500', Pictured Cliffs - 1575', Lewis - 1668', Cliffhouse - 2339', Menefee - 2911', Pt. Lookout - 4018', Mancos - 4177', Gallup - 5125'. Ran 122 jts. (5405.75') of 5-1/2", 15.5#, J-55, 8rd, LT&C casing. BakerLoked cement nosed guide shoe on bottom and differential fill float collar on top of 1st jt. Ran centralizers on the middle of the 1st jt. and the tops of the 3rd, 5th, 7th, 9th and 11th jts. Casing set at 5403.95', PBD at 5357.09'. Cemented casing as follows: Mixed and pumped 500 sks. (1945 cu. ft.) Class "B" cement containing 3% Econolite and 1/4#/sk. cellophane flakes. Tailed in with 200 sks. (236 cu. ft.) of Class "B" cement containing 2% CaCl₂ and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 3500 psi for 15 minutes. Test ok. Waiting on completion operations.
