- 1) Acidized existing perforations (5223'-34') with 1000 gal. 15% HCl.
- 2) Installed internally coated injection tubing with Arrowset I injection packer set at 5159'.
- 3) Filled tubing/casing annulus with packer fluid.
- 4) Performed MIT to 390 psi for 30 min. on 08/18/95. Pressure held. Test was witnessed by NMOCD representative Ernest Cardona.

This well is ready for water disposal operations.
