Elm Ridges Resources, Inc proposes to plug & abandon the South Bisti 30L #1 in accordance with regulations. Production equipment will be removed and well be plugged as specified. Perforate & squeeze will be used unless casing can be recovered over the specified intervals. Proposed procedure: Set a CIBP @ 5110'. Spot a 100' cement from 5100' to 5000' inside 5-1/2 casing. Gallup top @ 5060'. Spot a 100 plug from 2289' to 2389' across top of Mesa Verde @ 2339' inside of 5-1/2" casing. Spot a 175 plug cement from 1450' to 1625' across Fruitland/Picture Cliffs inside of 5-1/2 casing. Spot cement from surface to 375' inside 5-1/2 casing.
