MIRU stimulation co. Press tst lines to 2000#, valve leaking. Install new valve & press test to 3500# - leaked at chixson on wellhead. Bled off into well; replaced chixson. Press tst w/N₂ to 2900 psi - held good. Open wellhead & pmp 1200 gal/7-1/2% HCl acid w/2 gal/1000 corrosion inhibitor & 3 gal/1000 suspending surfactant. Displace w/42 bbls N₂ @ 3500 scf/min. Press brk from 2000# to 1400# during flush. ISIP 1200#; 5 min 500#; 10 min 375#; 15 min 300#. Shut well in, RD stim co. RU to flowback thru sep to pit.
