This well was drilled by Maralex Resources on behalf of SG Interests in November, 1993. It was not completed, and no pipeline has been constructed to the location.

SG is requesting BLM approval to plug and abandon this well; a proposed procedure for the P&A, along with a wellbore drawing, is attached. Time will be needed to obtain Working Interest owner approval, but SG plans to complete the P&A during the Fall of this year.
