Plans for the subject well are to complete this well (along with additional West Bisti Wells) and tie into an El Paso Natural Gas Gathering System. El Paso must lay two miles of CDP pipeline for this proposed gathering system, and the process for approval of this pipeline includes negotiations and concurrence from the Navajo Nation. El Paso's application for this pipeline was filed some time ago but as yet has not been approved by the Navajo Tribe.

It is the intent of SG Interests to complete all wells proposed for this gathering system with one rig once the El Paso pipeline is installed. Until that time SG does not wish to proceed with their plans or expense of completion. Therefore, we are requesting Temporary Abandonment status for this well (at the suggestion of Steve Mason, BLM, Farmington Office). No perfs or completion work has been commenced at this time.
