

Elm Ridge Resources Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and well will be plugged as specified. Perforate and squeeze will be used unless casing can be recovered over the specified intervals or there is evidence cement is in place behind the casing: Proposed Procedure as follows: Notify BLM office at 505 599-8907 24-hours prior to commencement of plugging operations. Pull all retrievable downhole production equipment. Set a CIBP @ 4950'. Spot a 50' cement plug on top of CIBP from 4900' to 4950'. Set a cement plug across top of Mesa Verde from 2196' to 2296'. Set a cement plug across top of Picture Cliff/Fruitland Coal from 1318' to 1518'. Set a cement plug from 361' to surface. Cut wellhead off. Install dry hole marker. Clear and remediate location.
