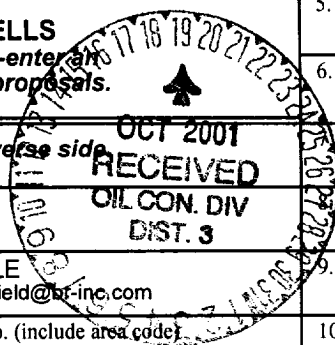

SI well. WOC. SDON.

(9-11-01) Cut off WH, cmt had fallen 160'. Install P&A marker, dump 30 sx Class B cmt, fill csg to top. RD. Rig released. Well plugged and abandoned 9-11-01.
