Move in & rig up Smith Drilling. Spudded 9-1/8" hole at noon 6/2/97. Drilled with water 0-140'. Circulate clean. TOH with bit. TIH w/3 jts. 7" 26# K-55 casing landed at 120'. Pump 5 bbls water. Cement with 50 sx class "B" cement w/2% CaCl₂. Displace with 4 bbls water. Plug down at 1645 hrs 6/2/97. Circulate 2 bbls cement. Shut in for night.

Nipple up BOP. Pressure test 600# - OK.
