

Drill to 6772' TD on 8/24/99. Ran IES & CDL logs. Run 4-1/2" 11.6# J-55 & 10.5# J-55 casing. Land @ 6772'. Stage tools @ 4638' and 2129'. Cement 1st stage 262 cu. ft. 65/35/8 containing 8# Gilsonite/sx and 1/4# celloflake/sx. Tail 218 cu. ft. class "H" containing .4% CD-32, .3% FL-52 and 1/4# celloflake. Cement 2nd stage 690 cu. ft. 65/35/8 containing 8# Gilsonite and 1/4# celloflake/sx. Tail 70 cu. ft. class "C" containing 6-1/4# Gilsonite/sx and 1/4# celloflake/sx. Cement 3rd stage 752 cu. ft. 65/35/8 containing 8# Gilsonite and 1/4# celloflake/sx. Tail 70 cu. ft. class "C" containing 6-1/4# Gilsonite/sx and 1/4# celloflake/sx. Circulate 2 bbls cement to surface on 3rd stage. Total cement volumes: 1st stage 480 cu. ft.; 2nd stage 760 cu. ft; 3rd stage 822 cu. ft. Job complete 8/25/99.
